### 1. The product name: Tegra 600 PP chamber

### 2. Applications:

The Wavin Tegra 600 chamber provides easy man access in traffic and non-traffic areas. Because of the high quality PP raw material, the manhole can be installed in the street, also in direct contact with asphalt. The flexible connections at the base allow 15 (7,5+7,5) degrees variance in angle of connected pipe. Properly sized corrugated wall with the right bearing soil protection against aquaplaning in the wet areas also play a role. Maximum allowed groundwater depth above invert H=5mH<sub>2</sub>O. Standard maximum installation depth – 6 m. The Wavin Tegra 600 chamber can withstand loads up to 25 metric tonnes (2,5 times the test load for traffic class SLW60 and about 4 times the realistic wheel load of a heavy truck).
